This Limited Warranty is applicable to the original consumer and is not assignable or transferable. If Product is determined by SUNWALK DOCKS to be defective, SUNWALK DOCKS will replace the Product in question with new Product of the same or equivalent value at no charge.

SUNWALK DOCKS warrants its Product against fading, breaking, corrosion, rust, or insect infestation under normal use and service.

THIS LIMITED WARRANTY does not cover damage resulting from accident, unreasonable use, neglect, alteration, improper service, improper installation, acts of God or any other causes not arising out of defects in materials or workmanship. Additionally, this warranty does not cover costs of labor, freight, taxes or other expenses associated with installation, removal or reinstallation of product.
